## CO ! STITUTIO ! OF THE ASSOCIATED STUDE ! TS OF FOOTHILL COLLEGE

#### PREAMBLE

We, the students of Foothill College, in order to promote the general welfare of students, to foster a spirit of democracy and unity in all student activities, to promote the growth and development of the college, and to better college- community relations hereby establish this Constitution.

### ARTICLE I ! AME A ! D PURPOSE

#### SECTIO! 1. ! ame:

The name of this association shall be the Associated Students of Foothill College (ASFC).

#### SECTIO ! 2. Purpose:

The purpose of the ASFC shall be to provide, within the limitations of the policies and regulations established by the governing board of the Foothill De Anza Community College District, for the material, social and governmental welfare of the students of Foothill College.

### ARTICLE II MEMBERS

As specifically provided in the By-Laws of this Constitution, there shall be elected officers, appointed members, and honorary members. All students paying the student body fee are members of the ASFC.

The Appointed Officers shall be designated in accordance with and shall perform duties as stipulated in the By-Laws of this Constitution.

### ARTICLE IV

#### **RULES OF ORDER**

Except as specifically provided for to the contrary in this Constitution and its By-Laws, Robert's Rules of Orders Revised (current edition) shall govern the procedures of the ASFC.

### ARTICLE V CAMPUS COU ! CIL

#### **SECTIO! 1. ! ame and Purpose:**

This body is responsible for the conducting of business of the ASFC and shall be known as the Campus Council.

#### SECTIO ! 2. Duties:

The Campus Council shall be constituted in accordance with and shall carry out the duties provided for in the By-Laws of this Constitution.

### ARTICLE VI EXECUTIVE BOARDS OF DIRECTORS

#### SECTIO! 1. ! ame:

The six executive boards of the ASFC shall be chaired by the appropriate Elected Officer, and shall be called the President's Board, Finance Board Administration Board, Senate Board, Activities Council, and Inter Club Council.

### SECTIO ! 2. Duties:

These Boards shall carry out the duties provided for in the By-Laws of this Constitution.

### **ARTICLE VII**

### **BOARDS-COMMISSIO ! S-COMMITTEES-COU ! CIL**

The ASFC shall, in accordance with specific provisions of the By-Laws of this Constitution, establish (or dissolve) such boards, commissions, committees and councils as may be necessary to the effective functioning of this association.

## ARTICLE VIII BY-LAWS

The By-Laws of this Constitution shall be the lawful means whereby the purposes and principles of this Constitution shall be implemented. It shall also address and specify the rules of charters, codes and regulations.

# ARTICLE IX ARTICLE OF CHA ! GES

## **SECTIO! 1.** Change to By-Laws:

Clause 1. By-Laws must be enacted, rescinded or amended by a two-thirds (2/3) favorable

Elections shall be held in accordance with the specific provisions of the By-Laws of this constitution.

### **SECTIO ! 2.** Appointments:

Appointive positions shall be filled in accordance with the specific provisions of the By-Laws of this Constitution.

## **ARTICLE XII I ! TERPRETATIO !**

## **SECTIO! 1. Intention:**

In the event that the ASFC or one of its members, or subsidiary units and organizations, requires an interpretation regarding the intention of the several provisions of this Constitution and its By-Laws, the question shall be submitted to the Dean of Students, one faculty member and one student of the Campus Council's choice who shall develop the procedures for rendering such an interpretation.

## **SECTIO ! 2. Enforcement**:

Interpretations rendered under the provision of the Article shall be binding under the terms of this Article.
